"**Sample\_file.tex**" – the file for your main text with instructions.

Change it at appropriate places and, eventually, rename the file. Please do not change the first two lines:

However we recommend keeping one initial version of the file for reference before deleting the main parts of the text.

The whole manuscript should be written in proper English. When you supply a hard copy, it should be printed single-sided.

**Graphics** should be included in EPS - format, e.g. with the command

```

**References and citations.** Please make the references according to the following examples. *Do not forget to quote also the editor(s) in the reference of a paper contained in a cumulative work (proceedings etc.). Please use the abbreviations of serials according to the standard of Math. Reviews.*

Please use the citation feature of L<sup>A</sup>T<sub>E</sub>X which automatically enumerates your bibliography items: To get the citation "Hmissi [4]" in your manuscript you have to type in your T<sub>E</sub>X file Hmissi \cite{Hm93} while the corresponding bibliography item is of the form

Please do not type it in the form: Hmissi [4].
